Scholarships

Financials

Matt Breslin presented the financial status of each of the following bank accounts (fiscal year July 1, 2023 – June 30, 2024).

NATO of Michigan (as of June 10, 2024)

- Ending balance: \$20,102.67
- Dues payments received: \$54,650
- Expenditures: \$46,781.87 (Karoub Associates consulting services, accountant contract services, website, meetings/conferences)
- A question was raised about how this budget compares to other years. Matt Breslin
 answered that is a little more lean, due to the loss of Goodrich Quality Theaters but
 still doing well for an association this size. He also mentioned the new membership
 campaign that NATO of Michigan will be launching to strengthen the association.

NATO of Michigan PAC (af of June 10, 2024)

- Ending balance: \$7,379.89
- Contributions received: \$2,500
- Contributions made: \$650 (contributions to the campaign fund of three legislators)

<u>NATO Community Fund</u> (vehicle for accepting contributions from corporations; funds can be contributed to legislative campaigns)

- Ending balance as of: \$2,836.65
- Contributions received: \$2,500
- Contributions made: \$0

NATO Scholarship Fund (after paying out the 2024 scholarships)

- Ending balance: \$8,257.70
- Contributions received: \$6,790
- Expenditures: \$7,500 (three scholarships at \$2,500 each)

Membership

Dana Lawrence shared that NATO of Michigan membership represents 28% of the market share (82 of 288 open move theatre locations in Michigan are members. This provides great opportunity for growth.

NATO of Michigan is preparing to launch an ongoing membership campaign to reach potential new members by:

- Establishing a membership committee to provide boots-on-the-ground insights and suggestions

- Collaborating with national NATO

Guest Presentation

Selam Ghirmani shared how the work of the Michigan Film & Digital Media Office (MFDMO) is supporting the media industries in our state and positioning Michigan as a worldwide production destination. Selam serves as director of MFDMO. She focused on, among other topics, the status of Michigan's film festivals and the opportunity for theatres across the state to host showings. This discussion centered on the possibility of NATO of Michigan providing MFDMO with a comprehensive, up-to-date list of theaters that Selam could share with film festival coalitions seeking venues for showings.

Legislative Reception

Following the Annual Meeting, NATO of Michigan hosted its annual Legislative Reception, where theatre leadership talked with state legislators and their staff about challenges facing the movie theatre industry and potential solutions. Far more legislators attended the reception than members. In preparation for the 2025 Annual Meeting & Legislative Reception, NATO of Michigan staff will focus special efforts on securing the attendance of more members for these important discussions.
